Prohibition, Prevention & Punishment

PENALTIES & PUNISHMENTS FOR OFFENDERS

- 1 Suspension from the college for a period of one month.
- 2 Debarring from appearing in the final examination.
- 3 Cancellation of admission.
- 4 Expulsion from the institution.
- 5 Debarring from participating in any SNA competition.
